### PROJECT OVERVIEW

**Project start date: 01.05.2023**

**Final report: 31.03.2025**

**End date: 31.03.2025**

The Internet has helped us in several ways to stay up to date with global events, keep easy communications, increase productivity, etc.

However, the fast transition has led to the incursion of portable ICTs into our daily life, with few awareness and social norms of how to deal with this. More often, we watch youngsters who are psychologically absent in the real world with an excessive use of the Internet. According to Eurostat numbers, 81 % of EU citizens use the internet at least once per week, and 72 % use it daily. This represents a sharp increase compared with the respective 56 % and 43 % measured 10 years ago. In 2021, 95 % of youngsters aged 16-29 years in the EU reported using the internet.

Many daily/social activities, social cues, etc. have been shifted in the digital world. We are witnessing a world of young ghosts with mobiles who are physically with their friends, family, school, jobs, etc., but, at the same time, they are more active on the Internet. In those moments, their few physical interactions can give the sensation that “they are there” but not really.

The Internet overuse and the absence in the real world, can fuel different negative behaviors. The range of behaviors observed in the growing population of internet users has in recent years become so complex that scientists have defined these phenomena as ‘Problematic Use of the Internet’ (PUI), for behaviors such as gambling, pornography viewing, social networking, etc.

The study “Cross-cultural study of PUI in 9 EU countries” scientists investigated the relationships between PUI, time, activities spent online, and psychopathology in 5593 internet users, from 9 European countries. The prevalence of PUI ranged from 14% to 55%. PUI and other behaviors are considered in our society as “normalized” practices without realizing the big problem our society is immersed in.

We need to start working on this situation urgently, otherwise we will fail our youth communities. If we do not act on this, we will contribute to the transformation of our society into a “phubbing society”.

- Objective 1: To CONNECT our experience, tools and know-how of negative behaviors on the Internet and its impacts.
- Objective 2: To ENGAGE youngsters and youth workers in the identification, counteraction and prevention of negative behaviors on the Internet.
- Objective 3: To EMPOWER youth communities in confronting “normal” negative behaviors.

### Work package n°1 - Project management

We will have three transnational meetings:

- **Kick off Meeting in Spain (June 2023).**
- **Mid-term Project Meeting in Italy (June 2024).**
- **Final meeting at the project ends in Hungary (March 2025).**

All three transnational meetings will be attended by 2 people per partner.

### Work package n°2 - Learning phase

We will carry out the following activities to provide tools and best practices in bad behaviors online:

**-3 day Participatory Training in Hungary** to transfer tools and knowledge in negative behaviors on the Internet. **01/08/2023 - 03/08/2023. 2 participants per partner.**

**-3 day Participatory Training in Italy** to transfer tools and knowledge in online addictions and detox techniques. **11/12/2023 - 13/12/2023. 2 participants per partner.**

**-Online workshop** to develop and test a framework to identify, prevent and counteract negative behaviors online. **01/09/2023 - 30/11/2023.**

### Work package n°3 - Creation of the REAL framework phase

To develop and test a framework to identify, prevent and counteract negative behaviors online:

**-Development of the interactive book** that documents the REAL framework. **01/07/2023 - 31/12/2024.**

**-Course in Spain** where the Framework and book will be evaluated. **01/07/2024 - 08/07/2024. 8 participants per entity.**

To provide a safe space for youngsters and youth workers to tackle negative behaviors:

**-Creation of a community. 01/04/2024 - 31/07/2024.**

The REAL Framework will be documented in an interactive book with an easy language that can be understood by any person not specialized in the topic. We will

develop free audio versions of the book for people with reading difficulties or impairments.

Work package n°4 - Dissemination campaign phase

To support and motivate project participants in becoming multipliers by transferring the REAL Framework:

**-Conference** in Hungary (06/01/2025), in Spain (13/01/2025) and in Italy (20/01/2025):

At least 40 people will take part in the 1-day event, including relevant stakeholders (local NGOs working with disadvantaged youth, activists, coaches, local authorities, public youth education, youth community, media).

**-Internal workshops** in Hungary, in Spain and in Italy (01/02/2025 - 31/03/2025):

Each entity will organize 4 internal workshops. At least 20 people will attend each internal workshop.

**-Consultation Sessions** in Hungary, in Spain and in Italy (01/02/2025 - 31/03/2025):

Each entity will organize at least 15.

To raise awareness of the importance in tackling “normal” negative behaviors:

**-Other dissemination activities** (01/05/2023 - 31/03/2025).

**Dissemination campaign**

More than 1000 persons from Hungary, Spain and Italy will have access to the REAL Framework. These 1000 persons will be reached through more than 200 multiplier entities and public figures who are part of the target audience. Furthermore, 5000 persons will be reached from other countries from Europe and worldwide. Both calculations were determined considering the existing number of national, European and international contacts from Tudás Alapítvány, Permacultura Cantabria, Oriol and associated partners.

Another important result of the campaign is that the project and the interactive book will be permanently available. Even after the project ends, youth communities will have free access to the project, interactive book and methodology, from any part of the world. We expect to reduce the economic, geographical and cultural obstacles offering online high quality materials free of charge. The Strategy of offering these materials in English and Spanish will increase the access of youth communities in Latin American countries and almost the rest of the world.

Developers will transfer the REAL Framework to youth workers and youngsters, so they can apply the new tools with themselves and peers. Associated Partners and participants will test the book, evaluating that the book is coherent with the course. Functionality and practicality of the book will also be analyzed. Each day, participants will provide their evaluations, constructive feedback, ideas and recommendations.

## PROJECT RESULTS

REAL framework.

Interactive book + audiobook.

Main target groups: Youth, youth workers, other staff from our entities, youngsters.

Result Languages: English, Hungarian, Italian, Spanish.

Deadline: December 2024.

The main result is a cutting-edge Framework for youth workers to identify, tackle and counteract negative behaviors on themselves and especially on the youngsters they work with. This Framework will be also available for any youngster who does not have the opportunity to be a learner in our entities (for distance or any other reason) and would like to obtain all its tools for free.

The REAL Framework will be documented in an interactive book with an easy language that can be understood by any person not specialized in the topic.

We will develop free audio versions of the book for people with reading difficulties or impairments.

Both formats will be free, fast and easy available in our social networks, websites, EU Platforms, etc. Any person from any part of the world will have access.

**INTERACTIVE BOOK CREATION:** All partners will participate

Tasks:

### INFORMATION ANALYSIS

Before training activities (WP2): Each entity will conduct an in-depth analysis of their tools, best practices and knowledge, as well as in other exemplary entities from their countries.

After training activities: Participants will compile and analyze the information learned to create the Framework.

#### WRITING

Our partnership agreed on the index and the basic chapters' content before the submission of this proposal. Our entities could suggest further changes on the index as long as they provide an added value. To keep ideas synchronized, developers will work with Google Drive, as many users can work on the same document, at the same time.

#### CONTENT REVISION AND CORRECTIONS

- All developers will review a chapter when it is finished.
- When developers approve the chapter, project coordinators will review it.
- After the test in Spain, developers will modify the content according to the participants' feedback.
- New changes will be validated and approved by our entities.

#### INTERACTIVE LAYOUT

The book will include interactive features and illustrations to catch the attention of youngsters. Interactive features will foster learning: embedded videos, QR codes, animations, responsive touch slider, podcasts, etc. It will have quizzes so readers can revise their knowledge learned.

#### TRANSLATION

One of our goals is to provide interactive books in Hungarian, Spanish, Italian and English to raise the attention of non- english speakers in our countries. Therefore, each partner will translate the book into its native language. The English version will also be published to reach other youth communities around Europe and the world.

#### AUDIOBOOK

The translated book will be recited and recorded by our organizations. The sound will be edited to ensure a high quality audiobook. PC will record the English version.
